Resolution of the Borough of Butler Board of Health in support of National Diabetes Awareness Month.

Resolution No. 016

WHEREAS, nearly 30 million Americans have diabetes, almost 90 million Americans are at risk of developing type 2 diabetes, and it is estimated that one out of every three children born after 2000 in the United States will be directly affected by diabetes; and

WHEREAS, type 1 diabetes, previously known as juvenile diabetes, affects 5% of all adult diabetes patients and is characterized as an insulin deficiency, wherein the body does not produce the insulin needed to provide energy to the body; and

WHEREAS, type 2 diabetes, the most common form, is characterized by a rising blood glucose level in the body, resulting in the body's misuse of insulin properly over time; and

WHEREAS, the seriousness of this disease is often underestimated but diabetes is the seventh leading cause of death in the United States, more than breast cancer and AIDS combined; and

WHEREAS, diabetes can lead to increased risk for heart attack or stroke, kidney failure, amputations, severe vision loss and nerve damage; and

WHEREAS, according to 2014 CDC Diabetes Report Card data, 694,000 New Jersey residents, or 8.4% of adults 18 and older, have diabetes; and

WHEREAS, a healthy lifestyle is important for individuals with diabetes and includes exercising, not smoking and maintaining a balanced diet and proper insulin levels; and

WHEREAS, this year's theme for Diabetes Awareness Month is *This is Diabetes*, focusing on the real-life stories of friends, families and neighbors managing the triumphs and challenges of this disease; and

NOW, THEREFORE, BE IT RESOLVED, that the Victory Gardens Board of Health does hereby recognize all of the above and November 2016 as *National Diabetes Awareness Month*, and urges all residents to increase their knowledge about diabetes by promoting education to decrease the risk of this disease.

Jaime said the owner doesn't mind maintaining this if everything is above ground and the grate can go back. Ismael said before the condos dumped all their water into the drain there was no problem. Now that they are bringing their water through now we have a problem. Who is legally responsible for maintaining the drain?

Ismael said everyone should put a grate on their own property and everyone would be responsible for cleaning their own section. Jaime said that was a good idea. The Planning Board sent me a letter telling me to remove my grate Ismael said.

Joan Cegelka — Did Rockaway have any programs for the people in Rockaway about diabetes? I don't know. I could find out for you. We never received the health calendar for the year from Rockaway. The issue with the grates, Mr. Feintuch sent the condos a letter about this because they have some type of drains underneath the road for their water. This was in 2014. The Attorney asked for their records on the maintenance of the drains which we never got. The condos drains may not be working properly. Before the condos we never had this water coming down. The water is now all coming down into the culvert. We may have to start all over again with getting the information from the condos and their maintenance on their drainage.

Valerie Williams - I think there was a grant for that drain. Ismael do you still have that? I don't know. If you don't have it maybe I have it at home. Rockaway Valley may be able to help with this.
