Jim Janone - When you do the minutes, you should say that Tara White nad Jim Glass are remote. Where is the money coming from for revising the Ordinances that the Attorney was talking about at the last meeting? The Clerk said this hasn't been looked at yet. When we get closer to putting something together and getting a price then we will see where the money is coming from. Won't you have another budget meeting? If we do, it won't be for this. If we are able to keep the garbage amount as is, then we won't need another budget meeting. We can introduce at a regular meeting. The only thing that budget meeting. we can introduce at a regular meeting. The only thing that was holding us up was the garbage. Council agreed to everything else in the budget. The new COVID relief bill that was passed, what is the Boroughs intention for using that money? We haven't heard that we are getting any money. I hear Victory Gardens will be getting \$144,401.35. Well, we haven't heard anything. We have nothing from the State or the County. It can only be used for maintaining services, provide aid to residents and small business, or invest in water, sewer or broadband infrastructure. I think at one time Verizon was in here asking permission to do something. The Borough is a dead spot for broadband. You can use it for that and for sewers. The Clerk said at the time Verizon came in they wanted to put a tower in and we said no. Jim said they now do something different. They are putting boxes up. Have we heard anything from the schools? I know they plan on going back April 12th. Anything on transportation? No, we are still holding hteir checks. They haven't called and ask where their money is. Page 10 hours of collection in the contract it sayswhat time the hauler comes in to town. I spoke to the hauler and he said that they don't leave the yard until 6 a.m. They are not in here at no 4 a.m.. On page 12 of the current contract there are 6 things that Rubinetti isn't doing. They should not bid again. They aren't bidding again. They have been bought out by Interstate. In the invoice from the hauler they are supposed to state: how many vehicles they have in here collecting, the tonnage, disposal costs, how much weight they are picking up, tipping fees, number of cubic yards. Where waste is going, the license plate numbers of the vehicles picking up in here and the payroll. What is the town doing about the emerald ash bore? I don't believe we have any of those trees in here the Clerk said. Forestry Division has an alert about this. I don't know the Clerk said but I do know that late last year they were talking about on the news and saying how destructive they are.
