CORRESPONDENCE:

The Clerk said she doesn't really have anything for correspondence. I wanted to let you know that Pat Reid from Community Development passed away. A very sweet, wonderful person that helped Victory Gardens out with all our applications and jobs throughout the years. Her viewing was tonight. Service tomorrow.

Another thing, we get calls down here where one Councilmember wants a certain number for another Councilmember. I want everyone tonight to write down their number. At the number that you want out for someone to call you on. This is just for Mayor and Council use. This way if another member of the governing body wants to reach you then we have a number to give them. I will pass this paper around and then you write what number you want to give and I will make copies for the Mayor and Council.

Recycling is becoming an issue again. Residents are putting their recycling out in bags. I have told DPW time and time again not to pick bags up. They do it anyway. They don't want everything blowing all over the place if they leave it there. When they open the bags to put them in our dumpsters they find garbage and food in there. What does Council want to do?

Councilwoman Hedgepath asked if they write down addresses? No, I gave them several notebooks and asked them to write the address down and we could send a letter but they never do that. We asked them to take pictures and that hasn't been done.

I have sent out fliers in thepast telling hte residents that they have to put recycling in boxes or some type of containers and it still gets put in bags.

Councilwoman Montes said they have to do their jobs. They have to write down where the bags are and then you can send a letter. Let the men know that if they pick up bags they will be written up.

Councilman Glass suggested that we do up a notice and if the DPW sees bags with recycling in it to write the address down and leave a notice in the mailbox. The Attorney said you can not leave anything in the mailboxes.

Councilman Lorenzo said that he looked at 372 Washington where the Clerk told us there was a problem with the sinking in the driveway of this house. We need to put a covering over it so no one falls in there. That is really bad up there. We don't want anyone getting hurt. Leon looked at it and we called the homeowner to let them know the town will fix it. The whole inside of the drain is gone. Eddie and Hector can not do it - it is too bad. There are cones up there so people know not to walk there. Leon went out to get quotes and the quotes have to be back to me by December 27th. What about putting a piece of metal over the opening? I asked Leon about that. The weight of cars going over it is only going to make it worse. The work Leon said can get done in the winter as long as the contractor doesn't have to go through feet of snow. Once we get the quotes in we can award and then get the company moving on it.

NEW BUSINESS:

REMINDER - Re-Organization meeting is scheduled for January 4, 2022.

2002 COMMUNITY DEVELOPMENT APPLICATION - Leon said that if we want to go for a Communmity Development application we have to get it in by January 7, 2022. He suggested doing the loop of Washington Avenue. did part of it already and he thinks we should do the other part. If Council is okay with this then I need a motion on it so Leon can get the application in on time.

POLICY & PROCEDURE MANUAL DPW - The Clerk said we just updated our policy manual. I want Council to think about this. I have mentioned this before and a member of audience also mentioned it but we really need to look at how vacation is being used by DPW in the winter. I don't know if we can tell them you can't go on a vacation in the winter or not, but we can't have the men out of here in the winter months and if they can go maybe we should say for only so many weeks at a time.

Eddie left for vacation tonight and he will be gone for a month.

Hector is taking his last personal day on the 30th of this month. We are closed on the 31st so recycling will have to be picked up on the 29th.

We have nothing in the policy manual that says they can't take time off in the winter months, nor do we have anythigh that says they both can't take the same day off.

Councilwoman Hedgepath said we can do blackout dates where they can't take vacations.

Councilman Lorenzo said that if one person is away then the other one won't be able to take the time off. We try to coordinate that the Clerk said. Hector is using his last personal day. We can not carry those

days over. They have to be used in the year they are given.

Councilman Lorenzo said they should be limited to how much vacation

time they can take at one time.

The Attorney said that maybe you want to say that no vacation will be given for DPW from December 20th through March 20, or something like that. If you want to write down what your thinking regarding this topic and give it to me then I can get it to the Attorney.

The Clerk said that she is the personnel person. The men will tell me when they want vacation or time off. As long as there is no issue I tell them it is okay. I can't stop them from putting in vacation for a month unless we have something in writing that says they can't do it.

AMERICAN RESCUE PLAN - I have spoken about this before and a member of our audience asked about it. We received money from the government that can be used for infrastructure items along with other items. We talked about doing a scope of our sewer lines to see the condition of them. I talked to Leon about it. I believe that most of our lines are good because we have worked on them over the years. But, we really should take a good look at them. We have the money to do it and it won't cost the town anything for the videos. Right now from the government we have \$76,000. I talked to Joe and he said we should be getting amother amount around the same figure. I asked Leon to let me know what the costs would be for this type of work. Leon would have to go for bids on a project like this. Leon said it costs about \$6,000 a day to scope and it could be as long as 12 days. Again, this is just a figure. Our town is smaller.

NEW BUSINESS CONTINUED -

AMERICAN RESCUE PLAN CONTINUED - Council said it was a good project and have Leon look into it and go out to bid and we will see what we get in the bids.

Attorney Feintuch said that he has been talking to the attorney for Nourish NJ that bought the old showplace property. They are working out an agreement so the town is assured of gettingthe tax money every quarter that the showplace was paying so the town isn't missing out on any tax money. Great.

The Clerk said that at the last meeting Councilman Lorenzo asked about the sewer/manhole cover by his property. He said he thought it was sinking in. I had Leon and Eddie go out and they both looked at it. Leon said there is nothing wrong with the manhole or the walls under the grate. There is a crack in the pavement. Everything is still very solid.

TRANSFER RESOLUTION - everyone has a copy of the Resolution. Joe gave it to me today. We did a Resolution at the last meeting but we didn't have som bills that will be payable this year. Debbie called around and got the bills so we knew how much we needed.

Jim Janone - I didn't get a chance to read any of this ordinance. I looked very quickly at the ordinance. I don't get the paper anymore. It was advertised in full. You are all in a rush to push this through. Why can't it wait until next year? I explained why. I can't comment on something I haven't seen.

Did anyone see the school report that the Dover Board of Ed came out with? They did a report and they said there will be a big influx of students coming into Dover. Taxes will go up. HOw come you haven't ever talked about doing a rent control ordinance. We have talked about that the Clerk said. That was awhile ago. You have to have a rent board and everything that goes with it. Years ago rents weren't what they are today. Percentage wisethey are the Mayor said.

The Attorney said the Clerk is correct. You have to have a well versed rent board that knows all the ins and outs of rent control. You also have a staff that has to do the work after they render their decisions. The Board maked the determination. That is all they do. You have to have staff to follow through on what they say and what has to be done. You need people that are educated in this type of thing. In regards to the discussion on recycling. Why don't you put stickers on the stuff the men don't pick up? We have them but they don't do it. If you do that then you can do stickers and penalties and fines. That is true the Clerk said but also whomever writes the tickets has to go to court.
