SECOND MODIFICATION/ADDITION TO POLICY and PROCEDURE MANUAL ADDRESSED TO VACATION LIMITATIONS (1/26/2022)

THE POLICY and PROCEDURE MANUAL WAS LAST MODIFIED AND ADOPTED ON JUNE 11, 2013

WHEREAS, the Mayor and Council of the Borough of Victory Gardens, Morris County, New Jersey have found it to be in the best interests of the Borough to Modify its existing Policy and Procedure Manual, and discussed the following change;

NOW THEREFORE IT IS RESOLVED AS FOLLOWS:

At Page 32: Under Vacations, the following language is to be added.

- All employees shall apply to the Administrator for the dates that he/she would prefer to take his/her vacation, giving the specific dates, last day to be on the job and the date that he/she will return to the job. Except in emergencies, an employee who advises of his/her preferred dates shall give a two week notice of such dates.
- 2) The Administrator has the sole authority to approve the dates
- In the event the Administrator does not approve the dates applied for, the Administrator and the employee shall set dates mutually satisfactory, in the event dates cannot be worked out amicably, then in that event the employee can bring the matter before the Administration Committee who will consider the issue and fix the dates that best serve both the Borough and the employee.
- 4) In no event will vacation dates be between December 20 of a given year and March 20 of the following year.
- 5) AS PROVIDED ELSEWHERE IN THE BOROUGH'S POLICY AND PROCEDURE MANUAL, CARRY OVER TIME MUST BE USED BY MAY I OF THE FOLLOWING YEAR AND NOT APRIL 1 OF THE FOLLOWING YEAR.

No one has said anything to us about having to do anything about the poles. These bags are what we have in the dog waste receptacles around town. They are plastic. These other ones that I buy are biodegradeable and they serve the same purpsoe. Yours cost 3½ cents per bag. Mine cost 2 cents per bag and are 9x13. You said the drive gears were seized on the snow blower. How can that be? These DPW are supposed to be maintaining all of our equipment. It sounds like a lack of maintenance. With the garbage contract there is a procedure for invoice nad payments. They haven't complied. They give no information with their voucher. There are 6 things they have to comply with and they don't. The Johnson & Johnson litigation, how come we never complied with it? We should have applied to be a part of that litigation. Rockaway Borough and a bunch of other towns did a resolution to be included with the lawsuit. We never heard anything about a lawsuit. What is it for? All a part of the opiod addiction thing. J & J is supposed to pay all towns money but it is over now and you can't get into the litigation. Community Developement block grants I know you say you cna't get money back for engineering. If you request proposals thru the bidding process they will cover costs for architectural drawings. I never said they don't cover costs. The Clerk said they cover what they cover. I believe sometimes depending on the projects they cover a cost for the Engineer. Are you giving the public copies of the update to the policy and procedure manual? No. You know you can't have that until Council is done doing what they need to do. A copy of the update will be in the minutes, barring any changes. It will also be in the paper.
