ALONZOS STEAK HOUSE - We have not received anything from Alonzos at this time. I've told them several times that they have to filetheir application with the State. I told them it has to be done before the end of the month. They have not paid the State their fees and they have not paid the town. I will put this one on for the next agenda in hopes that they have it done before the time otherwise they will not be able to serve any alcohol.

OLD BUSINESS:

SIGNED AGREEMENT WITH NOURISH NJ - The Clerk said she has the signed agreement with Nourish. It is good for 7 years. They have paid the sewer bill and they also continue to pay the taxes.

Councilwoman Cheatham asked when we think they will be up and operational? They are still gutting the place. They took about about 11 dumpsters. Once they call us for an inspection on the demo then they will submit plans and they will have to file fore the permits. once they do that, they can start puting the palce back together.

Councilman Glass said about the sidewalks going in, shouldn't we ask the people if they want sidewalks or not? The Clerk said it is a little too late for that. This project was talked about at a meeting if not more than once. Council agreed to have Leon do the grant. We were accepted and it has gone out to bid. No one had any other comments on it. This is a grant. These people are parked close to their houses now. If a sidewalk goes in they won't have anywhere to park. The Clerk said you can refuse the grant but you already approved it. You will still have to pay Leon for the specs, the maps, and whatever else work went into the project so far.

Councilwoman Montes said this is for the sewer? No for sidewalks on Coolidge. If you take 6 feet away where are they supposed to park? Coucnilwoman Montes asked if we are taking their property? It is town property Councilman Glass said. Would it be common courtesy to ask the people if they want it done Councilwoman Montes asked? The Clerk said Council should have asked that in the beginning before you said to do it. This was something that Council agreed to last year. Many years ago we had a whole thing with many meetings when we told all the homeowners that htey had to put in parking for their tenants. We worked on that for years. Many had to put parking in. A lot of the people that are back on Coolidge are tenants. The landlords never put parking in for them. They will have to take that up with the landlords.

Motion to open the meeting to the public by Councilwoman Montes, seconded by Councilwoman Cheatham and approved on verbalvote. None opposed.

Jim Janone - Jim asked if one the liquor license does it say there was a public hearing on it? No. It just says there was no objections from the public. I have questions with Alonzos. Can I get a final answer on the snow blower? Did we buy it? The Clerk said she knows for a fact that the town did not buy it. If we did there would have been a bill for it. The Mayor said it was donated. How come it didn't come to the Council that we received a donation? It doesn't have to. The Mayor asked when he brings tools down here and gives to the men for the garage I don't tell anyone when I did it. When will the cosed session minutes be approved so they can be released. The ones that were done a few weeks ago? The Clerk said the ones on May 20th? Yes. The Clerk said that everyone has a copy of the minutes. I did't have them approved yet becasue it was a personnel discussion and there has been no conclusion on the personnel matter. JIm said he put in a request to listen to the tape from that meeting. The Attorney said that closed session doesn't say who said what. It only states what the discussion was about and the final outcome. It doesn't say who said what. The Attorney said it is in violation of the law. It is public information. No it isn't. That is why it is closed session.

The Attorney said he is cautioning this body, what is disclosed in the closed session remains in closed session. The minutes are not to reflect what was said and by whom it was said. Closed session should not reflect what each person said. You can say this is what was discussed and who spoke on it but you can't put down what was said. You should not reveal whatever was said. That is why it is a closed session. You can argue freely without it being given to the public. Minutes can say the meeting was a closed session and who spoke but not what they said. You have a right to express your opinion without it being released to the public.

The Clerk said she did the minutes but I did them like I do all minutes. Before they can get approved for this meeting of May 20, 2022 I would have to redo them and then you can approve them at the next meeting.

Motion to close the meeting to the public by Councilwoman Cheatham seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

Motion to adjourn the meeting. Councilwoman Montes said she has a questions first. Kelly Jacobus got paid for an extra day. What was that for? The Clerk said I don't think it was an extra day. Sometimes depending on the way the days fall in the month, they may get paid for 11 days or 10 or 12 days. What does it say on the voucher? It says on the voucher it was additional time on June 6. Is it overtime because she doesn't get paid for overtime? It doesn't say on the voucher. I dont know if that was a whole day of extra hours or if it was 2. She was here with Joe. He called wanting to show her the computer and what needed to be done. The extra hours may be because of Joe coming in to show her that stuff. The Clerk said she ill reach out to Joe and see what he says and then the voucher listing can be amended. Council didn't say it was okay for her to do that with Joe. Its no different than what he did when Debbie Started. He has to show them what needs to be done.

Motion to adjourn the meeting by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.
