Councilwoman Montes said she is making a motion to hireLetitia Diaz. She is bilingual and she has a lot of experience with computers. Her company that she is working at now gave her rave reviews. Motion was seconded by Councilwoman Hedgepath. Roll call:

Councilwoman Montes said it is good for our town because she is bilingual as our town is over 50% of latin decent or hispanic. Councilman Lorenzo asked how much we are paying an hour? \$20.00 per hour. She is willing to go to school. Attorney Feintuch asked if anyone received the resume on this person? The Clerk said she did not get a copy of the resume. Council said they received it. The Clerk stated that she did not receive her resume. I just skimmed over the copy that Councilman Hale has. It says that she has worked from 2019 to 2020. Has she not worked since then? Coucnilwoman Montes said she is working now. Where? Coucnilwoman Montes asked the Clerk what the problem is? The Clerk said she has to work with the person you hired. The person you hired - the Clerk said she did not hire anyone. Councilwoman Hedgepath said to hire her. We had the other lady stay on until we found someone. The Clerk said she didn't vote. I don't have the authority to vote. The Clerk said I am looking at a resume that was just handed to me because I never got one. This resume does not say anything about a current job. Attorney Feintuch said as a matter of management perogative, wasn't it

Our CFO is here tonight and he would like to speak on this matter. Joe said that he has to work with this person as well. Itis highly irregular that a candidate is hired before the people that the person will be working with, had a chance to review the qualifications. Usually it goes to the Council after that.

Councilwoman Montes said that when she wasn't here and the hiring was donethe wrong way, we went out with an ad again to see if anyone would apply. Usually we bring 3 applicants names to the Council, if we have that many.

Joe said what is irregular is that in house interviews weren't done first with the people that would be working with this person and then have it go to

the Council for final review.

Councilwoman Hedgepath said that Debbe was here for the interviews for this person. We don't have you guys interview if we hire someone else. It is unfortunate that you are knocking her down before you meet her. She has a great letter of recommendation from her current employer and she knows computers and is very nice to get along with. And, we do need someone that is bilingual.

Councilman Lorenzo said that if you go by all the applications no one really had the needed qualifications except the lady that had to wait 6 months for the job because of her pension. Councilwoman Hedgepath said that she was looking for only something that was temporary.

Councilwoman Montes said we are trying to find the best person for this

town. That is what we should be doing.

The Clerkasked when this person will be starting? She has to give her current employer 2 weeks notice. Councilwoman Montes will get in touch with her and find out the date.

Councilman Glass wanted Council to know that the front end loader is out of service and we are going to try to get it fixed. It may cause a problem with pickup of recycling.

Motion to open the meeting to the public by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

Chris Trotsky - For the open position, can you explain to me about the previous employment that Jacobus has? The Mayor said it is a mute point, we just hired someone.

Jim Janone - Compliment to Council for hiring the right person forthe position. Bills from the Attorney for the Board of Ed litigation. It goes back to April of last year. How come? It was done in bits and parts. It would probably been better done in last year. It says something about the Town of Dover getting involved with this suit. Why are they in it? It impacts their tax structure. Dover made inquiry with the Judge and the Judge allowed them to come into the case. Is this Judge with the County? No, he is an Administrative Court Judge. Is there a case number on this? You have to look at the case and look it up.

Joan Cegelka - What was Debbie D's salary? When she left she was making a little over \$20 per hour the Clerk said. What did you hire her at? Joan said it was either \$12 or \$14 per hour. She came back after schooling and asked for more money and you gave it to her.

With raises Debbie D. reached \$20.54. Why are you starting a new hire at \$20 per hour? Why aren't you starting her at a lower rate? That was 8 years ago when Debbie D. started. Anyone that put applications in wanted \$20 or more per hour Councilwoman Montes said. The person we hired will be working for less than our temporary person. Duties will be the same as Debbie D's? Yes. How many applicants did you get? I commend you on getting the person in that you have. What was the main qualifications for this job? Councilwoman Hedgepath said the use of the computer and bilingual.

The Mayor asked for a motion to close the meeting to the public. Motion made Councilwoman Montes, seconded by Councilwoman Cheatham and approved on verbal vote. None opposed.
