At this time, Mayor Holeman asked for amotion to go into closed session for discussion on personnel.

Attorney Feintuch said there are 2 points that he would like to make. First, a question came up as to whom can call a special meeting. you have to give adequate notice of a meeitng which is 48 hours. We did 42. The Mayor has a right to call for a special meeting.

The Mayor called for a meeting for 2 reasons. The Council didn't give the Clerk direction as to when Kellys last day would be and when the new hiree will be starting.

There is not anything that says what the procedures are. This is a personnel matter and it is discussed in closed session. No one has the right to determine anything unless the Council votes on it.

Attorney Feintuch said there was no resolution hiring the new person. there was a vote taken to hire her but no resolution was done on when she would start, when Kelly's last day was and no mention of how much an hour this person would receive. Thisi was part of the reason this meeting was called. Councilman Lorenzo said then we should say that Letitia Diaz is hired as July 25 at \$20 per hour.

Attorney Feintuch asked who is going to break the newhiree in? Councilwoman Hedgepath said that when they wentthrough the first interviews, Debbie D said she has everything on the computer as to what needs to be done on a day to day basis, and she has a calendar marked for those things. Joe and Karen went over everything with Kelly. If they don't want to do that for the new person that is fine. Debbie D. told Kendyll that everything is on the computer.

Attorney Feintuch siad never mind as the Attorney, but as a friend, Councilwoman Montes said you are our Attorney and you give us legal advice. That is true but if anyone asked me, I would have given you some common sense advice.

Councilwoman Hedgepath said that before this whole process started with the interview, Debbie D. said that everything was on the computer. I don't have a problem with Kelly staying for the 25th to show the new hiree what to do. She can go over what she does for Joe and Karen. I don't have a problem with Kelly staying onthe 25th to show Letitia what to do. She can be hrere with her from 9-3 that day. If she doesn't want to, I totally understand.

Attorney Feintuch said he thinks egos got involved here. I don't know either one of these ladies. You had someone here for 7 or 8 weeks that was trained, had everythigh down pat, there were no complaints about her, and you just dismissed her. Now, in that regard, I got a letter from an Attorney.

Councilwoman Hedgepath made a motion that Letita Diaz willstart on July 25 at a rate of \$20 per hour and her hours will be Monday thru Friday 9-3. Kellys last day will be the 22nd and if she wants to stay utnil the 25th to break the new person in she can. The option is hers. Motion seconded by seconded by Councilwoman Cheatham and approved on roll call:

Attorney Feintuch said although the Council didn't approve her they did allow her to work and she was paid for that work.
