SCOPING OF SEWER PROJECT - Leon brought me in a map of the scoping of the sewer lines and what they found. I will pass the map around so you can see where the problem is.

Leon said that 20 feet below manhole 24 there is a point repair that needs to be done. Also, between manhole 15 to 16, sewer needs to be lined as a result of a many cracks and breaks in the clay pipe.

Leon has asked National Water Main for a proposal to adress these problems.

We can take the money from the Rescue Plan. If it doesn't cost above the bid threshold then we can have the company that did the scoping do the work. If it is a large amount of money we will have to go out to bid as soon as possible. Leon just wanted to get an estimate first from the people that did the actual scoping.

Thisis the section of Washington Avenue to where Washongton meets and all the side streets.

OLD BUSINESS:

SICK TIME POLICY & HEALTH BENEFITS POLICY (CURRENT) - At the last meeting Councilwoman Montes asked about the payout amounts for the 3 full time people. Joe gave me the infromation today and I gave it to Council tonight. I did give everyone the current policy manual pages where we talk about this. We should have the Attorney here when we discuss.

Councilwoman Montes asked if this change would affect Hector? No. Any changes would be for new people coming in. We will discuss at the next meeting.

Motion to open the meeting to the public by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbalvote. None opposed.

Jim Janone - Will a flier go out to the residents about the Dover Board of Education representatives coming to our meeting? I can do that however, they are addressing the Mayor and Council. I'm bot sure if they will take questions from the residents. Howcome we aren't getting proposals for the sewer? If we need to go out to bid we will. Leon wants to know an estimate. If the estimate is under the bid threshold then we can just do it on that. If it is over then we bid on the project. They are going to rip up the road. They don't have to rip up the road to put a liner in. If they have to totally replace a line then they will have to rip up the road. Who is responsible for the sewer lines at the condos? We are. Do we still have the policy for life time benefits after retirement? Yes. Didn't the State change the law? Yes for those hired after 2010. The State is saying you have to sign up for Medicare. Anyone that turns 65 has to sign up for Medicare. Employees will have to sign up for Medicare at age 65. They will also have to get the Medicare Part B.

PUBLIC PORTION CONTINUED:

Jim Janone Continued - If an employee refuses to get Part B because it costs them money, they will not be able to be in the State Health Benefits Program. So, in order for them to keep the coverage with us after retirement, they have to take Medicare Part B. What was the \$14,000 voucher for anderson & Denzler for? I'm surprised that no one asked about it. The Mayor read what the voucher said.

Motion to close the meeting to the public by Councilwoman Hedgepath, seconded by Councilwoman Montes and approved on verbal vote. None opposed.
