At this time the meeting was turned over to the CFO and the Auditor.

Joe said since the last time we met, I rather wait until next meeting to introduce. Increase is 3.08%. The average impact on a household would be \$65 a year. That is on a house assessed at \$115,000. The Auditor did not get a copy of the budget document. I will get something out to her. I want the Auditor to take another look at it so we will be ready to go at the end of the month.

When I started here things were charged to different line items that shouldn't have been. I had a lot of catching up to do. After tonights meeting,

I will have something to the Auditor so we can introduce on the 23rd. We can't adopt until June 23rd. The Mayor asked what is immediately for you, Joe? Thg end of this week? Next week? I should have it to her by the end of the week. I will send her the draft tonight. Please let Debbe know when you get that to the Auditor and this way we will know. The Mayor said he understands we are way behind on things already.

JOe said he was at a seminar today and there were about 65 towns present. Fifteen towns have introduced already. The rest have not. Being new here, I had to get last year caught up first. Now that I am caught up, I can move forward. The Mayor said we would have liked to have us be one of the This is the first time we have been this late 15 that already introduced. on introducing.

Joe said that if he knew that VG was so far behind I would have had reservations about taking the job. I have about 5 to 10 hours that I can give a week. The Mayor said that he wants to make sure this job isn't too much for Joe to do. Now that I am caught up, we should be fine. I know the other Joe did the best he could but that is what happens with a part time CFO. To start off behind was an issue.

The Mayor asked Council if they have any questions for Joe or the Auditor? There were no questions. The Mayor said then Debbe should have the infromation by the end of the week? Yes. I will copy her on what I send to the Auditor. I will have it out hte end of the week.

The Auditor said she will be away the when we introduce, but I will have someone here if you need. When I get the paperwork from Joe, I will review. I need the AFS documents. I will review before I go away.

Where is this tree on Franklin Road. It is by the shed on the churches property. are you sure that it is not on the churchs property? How are you going to tell homeowners what trees need to come down?

The Clerk said she missed something. Who said we are sending letters to homeowners? Councilman Glass said that he said that. If Leon determines that the tree is not on Borough property then a letter will go to the homeowner. The Clerk said we are not sending any letters out to homeowners unless Leon said there is a problem and they have to be notified. The washington Avenue project is that paving? Yes. Probably curbing if needed, speed bumps if they have to be redone. Where is this at? Roosevelt to the intersection of Washington and Washington. When is this litigation with the Dover Board of Education getting over with? Who is dragging their feet on this? The Clerk said it is on Dover. They were supposed to get an agreement to our Attorney for review. They have not done that yet. The Clerk said we just got the billing for the new school year and it is going up over \$3,000 a month. I sent that to Phil's office when I got it.

Joan Cegelka - Councilman Glass when the minutes were being approved, you said you had a correction for them. What was the correction? I abstained on something and Debbe put down that I said no. It doesn't make a difference Councilman Glass said.
