AMENDMENT TO CHAPTER 17-3.4 COLLECTION OF RECYCLABLE MATERIALS

- I. Strike section a. in its entirety and replace with following language:
- 17-3.3 All recyclable material shall be put in a receptacle which can reasonably contain the item(s). The container may be plastic, metal, composition material, or other material which is customarily used to contain recyclables.

Whatever the container, should not be more than (30) gallons; the contents shall not weigh more than thirty (30) pounds. The tenant or landlord is not limited to the number of receptacle containers placed at curbside; however, the recyclable material is limited to those items which are usual and customary found in residential units.

This Ordinance shall be a part of The General Ordinances of the Borough of Victory Gardens though codified and fully set forth therein. The Borough Clerk shall have this Ordinance codified and incorporated in the official copies of the Borough Code. The Borough Clerk and the Borough Attorney are authorized and directed to change any Chapter, Article and/or Section number of the General Ordinances of the Borough of Victory Gardens in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repeal of existing provisions not intended to be repealed.

NOW THEREFORE, BE IT RESOLVED by the Mayor and convened Council of the Borough of Victory Gardens that the Amended Ordinance dealing with recyclable material be Adopted on this day of , 2023.

Will the contractors be watched? Yes, Leons office will have someone there. Can't the DPW do the fence replacement? It isn't a big job. Budget will be next meeting? Yes.

Laura 64 Adams Avenue - This is for the house at the dead end of Adams. we are waiting to get monies back from our escrow. Theydid talk to Joe and Joe says he has nothing on the escrow account for this project. Joe told them there was no recordin the system forthis escrow.

The Clerk asked Laura to come in sowe cancopy all the paperwork and give to Joe. It will take a while to track this information because we will have to go back to all the professionals and see how much was paid to them for this project.
