\*\* At this time a motion was made to go out of the regular order of business so that we can introduce our 2023 budget.

Motion to go out of the regular order of business for discussion on the 2023 budget by Councilwoman Montes, seconded by Councilman Glass and approved on verbal vote. None opposed.

At this time the meeting was turned over to the Chief Financial Officer and the Auditor.

CFO Joe Kovalcik - This is the introduction of the 2023 budget. The increase this year per month will be about \$5.54 on the average home. This is better than what it was before. We received an additional amount of money in the relief fund of \$7,690. That is \$3,300 more than last year. We are going up \$67.00.

Last years local tax was \$1,895.00 and this year it is \$1,961. So that is an increasee of \$67.00 on the year for the local part of the budget.

Most of the dollars this year is because of pension and health care. Councilman Glass asked the figures that you are giving, what is this assessed on? A house assessed at \$172,000. Councilwoman Montes asked if the biggest part of the budget is pension and health care? yes, that is what drives the budget. The health care forthis year was about 23%. For next year the increase is around 8%. Councilwoman Montes asked if we have a good budget this year? Yes, we do.

# CORRESPONDENCE:

LETTER FROM RESIDENT REGARDING PARKING IN THE BOROUGH - The resident is complaining about the parking situation in here. The beginning of Monroe the Council made a no parking at any time. Vehicles are parked on both sides of the street, day and night, sometimes making it very difficult to get through.

There are houses with more cars than driveways, vehicles parked behind and on the sides of houses on the lawns that haven't been moved for months.

#### CORRESPONDENCE CONTINUED:

LETTER FROM RESIDENT OCNTINUED: The middle of Monroe has cars parked overnight constantly. People park on both sides of the narrow one way street. Close to the Roosevelt avenue intersection there are commercial vehicles parked on both sides of the street. There is a closed landscape vehicle/trailer that is sometimes left unattached sitting on a block of wood in the street. Also, there is a problem that vehicles drive in coming from the wrong direction. Please investigate these matters.

I am waiting for a new commander at the police barracks. They should have someone appointed within 2 weeks. The Mayor and I will go up at thattime and give all thisto him. Councilman Glass asked if we can tell them to have someone drive thru on Friday nights and Saturday nights. The Mayor said if anyone has any concerns write them down and give them to him and he will take it to the police when we meet with them.

Dover Fire was up there ans they said there were issues with the service coming down the side of the building. The pipes were rotted at the bottom and the wires were exposed. 2023 BUDGET INTRODUCTION - Already done earlier in the meeting.

RESOLUTION CHAPTER 48 STATE HEALTH BENEFITS - The state wants us to do this resolution for State Heath Benefits. Councilwoman Montes asked if this was for workers with 25 years and over? Yes. I called around to other towns and they no longer offer this to their employees. Years ago the other towns paid full time medical benefits after retirement but they don't do it anymore. that is correct. It is a big expense on our taxpayers Councilwoman Montes said. We shouldn't pay this for our retirees because they will have Medicare when they retire.

The Clerk said this has been in our policy and provedure manual for many years. We have talked about this several times over the years because I have brought it to the Councils attention. The most recent time was in October of 2022. Both at the meeting of 10/11 and 10/25/22. I said at that time you may want to change the policy manual before anyone new comes on. At that time, Council said no to leave it as it currently was.

Council woman Montessaid she wants this changed so that none of our employees get health benefits on retirement. A lot of the other towns don't do it anymore. that is correct the Clerk said, but it doesn't change for the employees that are currently here. It will be for any new employee coming in.

Councilman Lorenzo asked if it is mandated by the State? The Resolution? Yes.

Councilwoman Montes asked what is the Chapter 48 for? it's for the employees you currently have that are full time.

The Clerk said she will put it on the next agenda for changes to the Policy Manual. We can discuss at that time. Once the Attorney has all

the changes then he will do up a Resolution so the policy can be changed.

Councilman Lorenzo asked about Letty? She is part time. She is in another part of the pension for part time people. What happens if she goes full time? Then she will moved over to the full time pension benefits.

### NEW BUSINESS CONTINUED:

CHAPTER 48 STATE HEALTH BENEFITS CONTINUED - After the changes are made to the policy manual then no one that is full time will get health benefits when they retire. Letty is under her husbands health benefits soshe won't need ours. Councilman Glass asked how it would affect Manny? He will be covered if he is here for 25 years. He falls under the current policy because he was hired prior any changes. But he also would have to be here for the 25 years years.

What are they going to doif people put out all these containers and they blow over? They will pick the recyclling up just like they do now. Who will enforce? They will put stickers on the container and it will be left there. If someone refuses to comply with the weight limit what happens?

Councilman Lorenzo said if we have to buy a scale we will and the men can take it withthem. The Clerk said if once they get the sticker and then they don't take care of the problem, and if they leave the recycling to the curb then we can have the property maintenance person write them up.

Joan Cegelka - So, we have to go out and buy new cans? No. Use the ones you have now. If they are 60 poubds or gallons, then don't fill them all the way. These guys cna't lift 50 pounds? How much money do you make on recycling? None. It is all part of the contract with the haulers. You have to keep the recycling out of the mainstream garbage. Otherwise you will pay more for garbage collection. When did we stop getting money for recycling? It has been a very long time - years. Many years the Clerk said. People will start throwing recycling in the garbage. we have some people that do that now. Most people are good.

Definite on the Washington Avneue will be done before the kids go back to school Dover applied for a grant for the lead abatement, did we? No. Does anyone know about the report that the Water Department in Dover came up with? I haven't heard anything. Victory Gardens is mentioned. The report is about the water lines. They are going to be replacing lines in here. They are applying for a grant. They have until 2031 to get the work done. They will do 10% each year. The residents should know about this.

Joan Cegelka - We changed the things with pension years ago. Nothing with pension was ever changed. We made changes in the employees manual. Any changes in the policy and procedure manual we have. Any changes made were updated when they were made. Nothing was done with pension because the Council can't do anything with pensions. That is the State. For the parking Council has been working on this since Mayor palovitz was here. No one does anything. Can Mayor and Council write tickets in the areas of town that they live in? Councilman Glass said let Ron do it. The Clerk said it would have to be done at night. A lot of this goes on over night.
