Nisivoccia - Man Lee - This is the hearing for the 2023 budget. it has not changed from the budget that was introduced a month ago. It has been reviewed by the State and has been approved by the State for adoption.

The local tax lewy \$807,776.00. For the average home assessed at \$172,000 that equates to approximately a \$5.15 increase per month. Compared to the previous years the main increase is health benefits and insurance. I am here for any questions the Council may have.

No questions from the Council. Councilwoman Montes said we have a strong budget and everything looks good.

Jim Janone - Did we get any additional increase in interest? Rates have gone up and I noticed some towns have an increase in their revenue. auditor said we aniticpated the same amount as the previous year - the anticipated amount was \$8,000. In 2022 we realized \$11,000. Did anything else go up besides health insurance/other insurances and was there anything else? We got a little more in State Aid that is why your increase is not as big as it could have been.

No other comments from the bublic.

COMMITTEE REPORTS:

Streets & Roads - Councilman Glass said the fence is down and taken away. It looks real nice up there. DPW cleaned up the area. I want to thank Councilman Hale and the Mayor for bringing this stuff up at the 1st meeting when I wasn't here. We were late coming in tonight. we went up to look at what the contractors were doing. They are paving and they are leaving debris all over the sidewalks I was out for about an hour cleaning the area up and Hector and Manny cleaned up the rest and that took them about 1 1/2 hours each. We were talking to Mike from Leons office and told him the contractor will be charged back \$500 since we had to clean up. We told them to have them clean it up tonight.

Councilman Lorenzo asked who is leaving the debris? The contractor. They rip up the road and asphalt goes all over. they cleaned the one side but they didn't clean the sidewalk side. They leave the stuff on the tools and they put the tools on the sidewalk and then it falls on the sidewalk and stays there. The company is on notice to clean stuff up or they will be charged back. Have the trees been trimmed up by the firehouse? They said they would try to be in within 2 weeks. Also, Councilman Glass said they didn't get notice on the road being closed for speed bumps. They did notice the Clerk said. They don't notice for every step of the work. They have their signs up. Other than that, the contractor is doinga good job.

No other reports from Council.

Motion to accept all reports by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

NEW BUSINESS:

DEDICATION BY RIDER FOR PUBLIC DEFENDER - Already done earlier.

DEDICATION BY RIDER FOR LEA ACCOUNT - Already done earlier.

CANNABIS LICENSE APPLICATION - The attorney said we are not taking any votes: tonight. This is just to discuss withthe Council if they approve the application as prepared.

Councilman Glass gave an over view of what happened at the Planning Board meetings before these applicants came to Council. Coucnilman Lorenzo said it looks like Tangerine Tree has more problems than the other place. The other one there doesn't seem to have any problems. (A lot of the discussioin every one was talking over the others and it couldn't be picked up by the recorder). Both applicants have to go back to the Planning Board once Council passes what they have to do.

The Clerk said she has mentioned several times at the meetings that she has the plans and that Council should look at them. Not one person came in to look at those plans.

The Attorney said we have both applicants here tonight maybe they have something they would like to address the Cuoncil on.

Motion was made to open the meeting to the public so the applicants can say something if they want to.

Motion made by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

AnnMarie rizzuto from weiner Law group. They erpresent Tangerine Tree. The Planning Board had an initial determination which was basically saying that the site was zoned for the cannabis and the property was available for the cannabis. There is still another big part of the job that the Planning Board has to do. Their initial resolution comes before the Council. My understanding is that it will go back to the Planning Board .

NEW BUSINESS:

CANNABIS APPLICATION CONTINUED - The Councils decision is to have us file your new application which comes with a lot of other paperwork for us to fill out. All the paperwork will tell you how the operations will go. We will do the new application and we will submit with the \$10,000 payment. You have to decide if we are okay to have the applicant in our town. Once you approve or rejusct the applicant, then the applicant goes back to the Planning Board for a full site plan review and approval.

Jim Janone - They are coming before Council to get approval of their applications and then it goes back to Council. Correct? Yes. Mr. Glass has given some misinformation. I've looked at the Planning Board resolutions and the packets from each applicant. Everything is in the there if you looked at it. You are asking questions or making comments on things that have already been addressed. The Attorney said this is all new to everyone up here.

Alex from RS Operations - As applicants we have to work thru the towns and the State. We are waiting on both bodies of the Borough. We work on a time line with the State. we filed for an extension which we were granted. We are paying more expenses even before this goes forward or not. We have to secure the spot and paying rent on a space we aren't in yet. Both applicants want to be here and open our stores.

The Clerk said so what happens is that the applicants have the application that the town Attorney drew up. They fill that out with the application fee, give it back to us so we can review. Once Council agrees or disagrees it goes back to Planning Board.

Motion to close this portion of the meeting to the public by Councilwoman Hedgepath, seconded by Councilwoman Montes and approved on verbal vote. None opposed.

The Clerk said everyone got off track. All we were suppose discuss was whether or not the application before you - the blank application - was okay with Council so it can be given to the applicants. Council okayed the application for the applicants.

CANNABIS RESOLUTIONS FROM PLANNING BOARD - Nothing tonight for this everyone was given a copy of the resolutions so they can see what the Planning Board did.

RESOLUTION ON HEALTH BENEFITS AFTER RETIREMENT - The Attorney made changes to the heatlh benefits part of the policy manual. We haven't received the update yet. That was for the medical insurance after retirement. Councilwoman Hedgepath wanted to look into the part about separation. Part time employees get no health benefits even if they were full time and went to part time.

RESOLUTION FOR A PART TIME CHIEF FINANCIAL OFFICER - Councilwoman Montes said she spoke with our CFO today. He jsut got out of the hospital today and he will continue to work for us so at this time I don't think we need to hire anyone else. The Clerk said you can't talk about his condition because of HIPPA laws. He will be back in 3 weeks. The Mayor said we will table this.

HOUSING OFFICER - Councilwoman Hedgepath said she asked to have this back on the agenda because the people that were misplaced when the tree fell on the house are having a lot of problems withtheir landlord. The landlord owns 13 properties in VG. The tree got hit with lightening the week before it fell on the house. The landlord never did anything. It did something to their water heather and furnace. The house is full of mold and this landlord isn't doing anything about it. We have 2 families that are misplaced right now. If we don't fight forthem who will? He has other properties that are in bad shape also. We need someone here.

The Attorney said a housing officer will help with the students in here. Councilman Glass asked if the health inspector takescare of mold? Yes, if the residents complain. They are afraid to complain about these conditions for fear the landlord will retaliate.

The Clerk said that the health department can go in ifthere is a mold issue and infestation of any kind, no water, no heat. Someone has to complain about those conditions. A housing officer can only go into a house ifthere is a complaint. That job is for over crowding. When they have outside problems that is Ron for property maintenance.

NEW BUSINESS CONTINUED:

HOUSING OFFICER CONTINUED - Councilwoman Montes said we have been through this before. we go back and forth about what we should do. A part time person would be good for the town at a reasonable price.

SEPARATION POLICY & PROCEDURE MANUAL - Councilwoman Hedgepath said that her job goes by the State. If you get terminated you don't pay sick or vacation time. If we have a resolution that says we pay out then that is different. The Clerk said we do have a resolution.

Put this on for the next agenda.

Motion to open the meeting to the public by Councilwoman Montes, secoded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

Joan Cegelka - Who took over Charlie Woods position for reconciling the books? No one. The CFO took it on. What did Charlie get paid? I think it was like \$25 per month. It took him about an hour to do. It was mentioned at the last meeting about Council writing tickets for the parking on the streets. What ever happened withthat? State Police said they are the ones that write the tickets for those cars parked on the streets. Council does not have the authority. When does Board of Health meet? every quarter. Did they meet this year? They did their reorg and then had a regular meeting after that. Will you have a meeting this year? I think so. You should do something for fire prevention week. we use to do it and we need to do it again. There are no planning board minutes on the website. I will speak to Letty tomorrow and ask her ifshe put them up.

AnnMarie rizzuto - There are preferences in the state law for the cannabis. Tangerine Trees application is different from the other applicants.

Jim Janone - You took the fence down at the leaf dump. Are you putting up another fence? Whatever Council decides. Who is the current commander? No one they have a desk seargent. they are supposed to be getting a new commander. they will let us know when that happens but I call them to check. In the LEA account you need to put something on for fire prevention. What are we putting in speed humps or bumps? Speed tables. Can you have chickens in the Borough? No. I saw some in here. They are caged up outside. We have pot holes near the drainage by Jefferson Avenue. When will the sidewalks go in? The week of September 7th thru the 14th.

Motion to close the meeting to the public by Councilwoman Mones, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.
