## DEPARTMENT REPORTS:

Building Department - 4 permits issued. Total value of construction was \$26,507.00

Property Maintenance - Everyone has a copy of the report.

Registrar - 2 marriage licenses issued. Total collected: \$56.00

Councilwoman Hedgepath said she thought marriage licenses were free? Not any more. The State waived the fee during covid. They have now reinstated the fee.

## COMMITTEE REPORTS:

Councilman Hale said he has 2 estimates from Councilman Glass for the bucket loader. This is for the bucket itself because the one that is on it now, has rusted away and we can't use it. Everyone received the first quote for \$4,963.32 from ASB Services. jim got another quote from Skid Pro for the same thing and the cost was \$2,100.

Councilwoman Montes said this Saturday, March 30 is the Easter Party at the firehouse. Time is from 3-5 pm.

Councilman Lorenzo said he had questions about trees on private property. There is a tree on Roosevelt Avenue. There is a big branch hanging down in the tree that broke off. The rest of the tree is holding it up. It is not a Borough tree. We have to tell the people to cut it before it falls on someone.

The Clerk said she had a note on the Attorneys agenda tonight about trees also. We had two trees on Franklin Road, that were not Borough trees and they fell down during 2 different storms we had. One of the trees that blocked the road, our DPW was able to cut it up and remove it. The other one was big and DPW couldn't do anything with it. That too was blocking the road. It had to be removed. Councilman Glass called Master Services in to have them remove it. It cost the town \$860.00 for removal. This wasn't our tree and we shouldn't have to pay for it. It was blocking the road and trafficand it had toget done. My note to the Attorney was asking if we have to do an ordinance so that if the trees fall the homeowners are responsible and they have to pay for it.

The Attorney said you do not need to do an Ordinance. You can go back to the homeowner and bill them. So the bill we have, the Clerk asked, we will pay for it but I can send the bill to the homeowner and have them pay it? Yes.

Coucnilman Lorenzo said there are many trees in town that are dead and they need to come down. The Attorney said to put something in a flier telling the residents to check the trees ontheir property. The Clerk said she has a flier started with that on there. It's been on them before and no one ever pays attention.

The Clerk asked Councilman Lorenzo what house he was referring to? He said on Roosevelt. The Clerk asked him to get the number so I know who to send the letter to.

Motion to accept and put on file all reports by Councilwoman Montes, seconded by Coucnilman Lorenzo and approved onverbal vote. None opposed.

#### NEW BUSINESS:

Both the RVRSA ans Dover Board of Education litigation will be discussed in closed session at the end of the meeting.

GENERAL CODE ESTMATE FOR UPDATES TO CODE - The Clerk said she gave everyone tyhe estimate that General Code sent us. It was to update 3 ordinances that we have passed last year. It is for the Cannabis Ordinance, Solid Waste Management Ordinance and the Privately Owned Salt Storage ordinance.

The Clerk said General Code wants us to do this every year. I don't think we need to do it every year. The cost they are saying is between \$1,725.00 to \$2,050.00. It also covers the ocst of printing the supplemental pages of

16 sets. I don't really think we need to do it every year.

The Attorney said he doesn't think so either. We can do it every year ourselves. When we do an update we just put it in our book. So, the Clerk said everyone gets a copy of the new ordinances. So all they have to do is put it in their books that they/currently have? Yes. You cando this every year but do it in house. If its an amendment to a current ordinance just notate that on the ordinance.

Councilman Lorenzo asked if he can aska question about the property maintenance report? There is something on this report that says a resident

needs to remove 10 trees from their property. Why do they have to be removed? The Clerk said that is the house across from the leaf dump. They couldn't afford to take all the whole tree down so they cut the tops out of all the trees. So the trunks are left standing. The reason they did that was because during storms trees fell and ruined the neighbors fence and I think it hit a part of the car. So they cut the tops out of all the trees so they wouldn't fall on anyones property. I guess Ron says they are rotting and the rest of the trees need to come down.

The Attorney asked if we have an ordinance that addresses this? Clerk said no that is why I gave you the note asking if we need to address this in an ordinance. The Attorney said we can't do anything about it. The Attorney said these are private grievances and the town should not get involved in them.

Mayor Holeman said this is the problem with the trees. We can look at them and say they are rotted but it is private property and we can't tell them to remove them.

Councilman Suarez said that is the way it shuld be. We can't tell residents to remove them. When I moved here there was atree between my house and the neighbors house. It was damgerous and I paid for it. First I cut the top only and then later on took it down completely, I didn't want to get sued. Everyone is liable for thier own stuff.

Councilman Lorenzo said but when it is a matter of safety then we have to say something about it. It's the same thing. If it is on their property we can't tell them what to do.

The Attorney said it is the responsibility of the homeowner. You don't go after their insurance, you go after the homeowner and they in turn will go to their insurance. The Attoreny said if your neighbors trees are hanging over your property you can cut those branckes. The Attoreny said if it comes dow nto where we have to remove the tree ourselvesthen we bill back to the homeowner. It is the responsibility of the homeowner.

Jim Janone - Voucher # 3-28 for Ridgeback Venture what was that for? The lien redemption we just did. Is there any reason why the public can't have a copy of Resolutions or ordinances before you introduced or adopt? The Attorney said the Council will take that under consideration. all other towns do it. No they don't. Some do, most don't. The price for the new bucket for the machine how much was that? ASB was a cost of \$4,963.32. Skid Pro \$2,100.00. When you were talking about the General Code I think there is something in the Clerks duties that says it is up to the Clerk to do. No they don't. If you find it show it to me the Clerk said. Do we have anything in our Ordinance that says the property owner is responsible for their trees? No. So if you send that bill to the property owner and they say they don't see anything in the ordinance and they say they aren't paying it what do you do? The Attorney said it is a matter of law. It doesn't have anything to do with local laws it is common law. I have a suggestion about the trees since you have talked about them so much tonight. Other towns hire an arborist to check their trees. They inspect all the trees, in the towns right of way. An arborist, the Attorney said can tell you the condition of the tree but he can't tell you who owns the tree. No, that's true. The Attorney said he doesn't think there is an issue. The engineer let's us know when he gets the list from us if the trees are in the town right of way. If they are and they are rotten or broken where limbs are falling off the trees we take care of them. The Clerk said we have taken down many trees over the course of the last 10 or 15 years. They are all trees that have been in the town right of way. We continue every year to remove trees unlike many other towns that don't do it. If trees overhang the road way and they are a danger, then the town can cut the limbs or branches. as long as it is in the towns right of way we can trim it back.

Councilwoman Montes asked if people need permits to take trees down? We have a paper for them to fill out at no cost. It's just to let us know howm any trees they are cutting down and what type they are. The Construction Official is the one that gives the permission forthem to do it.

Motion to close the meeting to the public by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

Motion was made to go into closed session by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed. Closed session is for discussion on the RVRSA litigation and the Dover Board of Education litigation.
