Jim Janone - What was the Resolution for that you did tonight? Washington Avenue Road Improvements. Front end loaders, they are not welded on. We are fixing the bucket itself. The bucket is cracked. Did we ever find out about the issue with the water outage from Dover? I called them they said they will let us know but sometimes it is an emergency and they can't notify. Dover Board of Education where are we withthat? They have a tax increase for the Board of Ed. Attorney Feintuch said he spoke with Dovers attorney and they are still working on figures. We are holding about \$600,000. They are questioning whether or not we are entitled to that. Part of this whole thing has been settled but there is still a part of it that is open. Who keeps the accounting of escrow accounts. Supposedly the CFO. Who tells the applicant what they have to give us for escrow. Usually Leon will say what he projects his inspections will be and they set an amount. Mikie Sherrill is getting money for towns. You see it all on facebook. Why can't we get money from her? Who can ask her about this? The Mayor will. There is a bus that stops right on Washington Avenue in the morning and it blocks the roadway. People are trying to get out and other cars are coming in and they are blocking the road so no one can pass. They park most times on South Salem Street but htis one parks right at the bottom of the hill. The last thing I have is Alonzos. They are still having parties over there until 1 in the morning. There is loud music. People are arguing over there. Why were they given permission to stay open so late? They were not given permission.
