CORRESPONDENCE:

STATE OF NEW JERSEY - We received another letter from the State regarding our back payments on health benefits and pensions. For our active members, we owe \$52,507.77. For our retired members we owe \$5,042.80. This has been going on for awhile so I decided to take time and call them myself to see how we can get this matter resolved. I was on the phone with them for almost 2 hours.

From what they told me, we are over a year behind in our payments. Joe has said that he is having a hard time trying to do this electronically. For some reason the payments aren't going through. So I asked if since we are having a hard time doing it electronically, can we write a paper check? They said yes.

They also gave me a phone number for Joe or Jason to call to fix the account if there is a problem submitting payments.

So, I told the person that I spoke to that we would send 2 different checks. One for the active members and one for the retiree. They said that would be the best way to do it.

So I need to find out from Council if this is okay with you and that I send both checks to the pensions/health benefits.

The letter was signed by the Mayor and myself. I then received a letter back from her stating that the monies are forfeited based on the letter she received from me.

It states in part, that the Council wanted Leon to try for a generator. Leon spoke with Community Development and they do not fund generators. Stated at this time was that the project we are applying for is redoing Roosevelt Avenue.

It looks like weeds to me. Under the cannabis there was suppose to be some looking into what is considered an inkind gift to the Borough. I didn't know if the Attorney or the CFO was looking into it. It was the CFO. He said he would let us know what they do in his other town and he would get back to us. Did he? No. This notice from the Dover Water Department - I'm sure everyone got a copy of this letter. Do they expect people to go into the hole and try toget a picture? I don't know. I will have to call them and see what they want done. We should tell the water department that we should be an exception. The majority of us have the pits outside for the meter. You also need a special wrench to open it up. What happens if you do have lead? Dover applied for a grant to getthis replaced. Dover will pay for part of the cost and probably the homeowners will have to pay for the rest. They should send their own people up here to have them do this inspection.
