Every time they have to pull a load out it would be an additional \$200.00 per pull plus the cost at the transfer.

I suggest that if we do sell it to start the bids at \$5,000. It does need a battery.

at \$4,000.

There are some other lights out and we need to get an estimate on all the lights at one time. Councilman Glass said he will talk to the Mayor about it. We had an estimate but we added to the list so he has to update it and give us a new price. Is there any update on the manhole issue? Leon went out and inspected it. He said it is not a tripping hazard. Does anyone know why Dovers leaf vac was in our town? No one was aware of it.

Motion to close the meeting to the public by Councilwoman Montes, seconded by Councilman Suarez and approved on verbal vote. None opposed.

Councilwoman Montes said she would like to thank Councilman Suarez for all his help with the Halloween Party. We had about 50 kids. Councilman Suarez said the slide at the playground looks like there is mold on it. Have the DPW guys look at it and see if they can clean it up.
